Amb. Dr Pindi Hazara Chana represents the outstanding and amicable practical experience in leadership and administration to national and international development endeavours. She has served the United Republic of Tanzania in different capacities across national, regional and global levels.

From 2014, Amb. Dr. Chana has held different ministerial roles in the United Republic of Tanzania. She served as a Deputy Minister Community Development Gender and Children in 2014/2015, Minister of State Policy, Parliament and Coordination in the Prime Minister's Office between January and March 2022, Minister of Natural Resources and Tourism (April 2nd, 2022 to February, 14th, 2023), Minister Culture, Arts and Sports (February, 14th, 2023 to August 31st, 2023) before her appointment as a Minister of Constitutional and Legal Affairs from September 1st, 2023 to date.

Dr Chana has remarkable political calibre that enabled her serve as Member of Parliament in the National Assembly of Tanzania in different electoral phases: 2010/2015 and 2020/2025 through Chama Cha Mapinduzi – CCM, her political affiliation. She also has held different positions within CCM including being a Secretary for International Relations (SUKI), Chairperson, Parliamentary Committee on Constitution Justice and Good Governance (2010/2014)

In diplomatic and international relations Dr Pindi Chana has served as Tanzania High Commissioner in Kenya Ambassador (2017/2020), Permanent Representative to UNEP & Kenya (2017/2020) and UH - HABITANT (2017/2020) both at the Tanzania Embassy in Kenya. Amb. Dr Chana has also served as a Commissioner of the Joint Finance Commission between 2009 and 2013 and the Council Member of Mbeya University of Science and Technology (MUST), National Art Council, Muhimbili University of Health and Allied Sciences, and Mwalimu Nyerere Memorial Academy between 2012/2013, 2009/2013, 2008/2013, and 2009/2010 respectively while serving as a member of the Tanzania Committee which was collecting opinion on fast tracking East Africa Political Federation in 2008/2009.

Being a Tanzania Research Education and Environmental Care Lawyer 2000/2010, Amb. Dr Pindi Chana successfully strengthened the program, as a Legal Officer, Iringa District Council 2000/2005, she fostered team cohesion and enhanced staff morale, and as Law firm, UK Secretary 1997/1999 she enhanced strategic and innovative partnerships, and achieved the highest level of program delivery that makes her a distinctive work partner.

Apart from being a competent lawyer, and stupendous administrative personnel, Amb. Dr Chana is rich in knowledge diversity for she served as Barclays Bank UK Teller between 1995 and 1998, a cashier at Coca Cola Co. Ltd in 1996 and 1997, and a Russian bank Teller from 1994 to 1995. As an academic, Amb. Dr Chana, has published and presented papers across national and international symposiums from Political Rights of Women, Peoples' Friendship University, Moscow in 1999 to Addressing United Nations General Assembly in New York, USA 2014 during debate on the New Partnership for African's Development (NEPAD) and the battle against Malaria in 2014.

A Tanzanian national Hon. Amb. Dr Pindi Hazara Chana possess exceptional skills in practical legal training and management of constitutions contracts and holds a PhD in Law from Mzumbe University, LL.M from the university of Dar es salaam and LL. B from Peoples Friendship University (Lumumba), Moscow Russia with diploma in Multilateral Environmental Agreements from University of Eastern Finland and her recent Certificate of Leadership from Uongozi Institute in 2022. Dr Chana believes in life-long learning for personal and sustainable national development.
